SECTION 4: FIRST AID MEASURES

Description of necessary measures:

Immediately flush eyes with plenty of water for at least 15 to 20 minutes. Ensure adequate flushing of the eyes by separating the eyelids with fingers. Get immediate medical attention. Eye Contact:
